Her current role as the Geriatric Emergency Management (GEM) Nurse allows her to work closely with clients, caregivers, the interdisciplinary team and community organizations.

By identifying risk and gaps in service, she understands that it's not enough to observe a challenging situation.

"It's important to listen, ascertain the needs and goals of the individual and family members, and work with them to develop a plan of care to meet their needs," said Hicks.

Karen has been a member of Age Friendly Peterborough (AFP) for many years and sits on the Basic Needs committee. She contributed to the AFP 2017 Action Plan for Peterborough and has been an active member of the planning committee for annual Senior's events.

"I was chosen as a member of the Health Quality Ontario Delirium Quality Standard Advisory Committee in 2019," added Hicks. "I proudly serve as the current GEM Nurse spokesperson to the Joint Services Operating Committee for the Seniors Care Network."

Instrumental in developing and implementing a Geriatric Fellowship in the Emergency Department, Karen has successfully supported 8 Registered Nurses to understand more about senior friendly approaches and assessments.

"I appreciate the incredible work that Community Care does in our community. I learned more about the organization through my employment at PRHC and I felt the need to give back to my community by serving on this Board," said Hicks.
